Sir,

With reference to letter referred to above, it is my pleasure to inform you that the Executive Council of this University in its meeting held on 29-10-2004 has accepted the recommendation of the Academic Council on the basis of the reports submitted by Dr.Kirti Singh, Chairman of the Team to grant provisional recognition to your institution to start College of Agriculture, at Panchvati, Nashik.

As per the new regulations issued by the Government of Maharashtra vide G.R. No. कृषिवि-२००३/प्र.क्र.१४५/२०-ए, dated 8th of August, 2003 and norms of ICAR before granting final recognition, it is mandatory that the institute should have 40 ha. of land in the name of the institute as per the land records of the revenue department. Further all the infrastructure facilities required are to be completed and made available by the institution before the permission is granted to admit the students.

You are therefore, requested to send your acceptance of this condition and your willingness to start the above mentioned college at your institute. If you are willing to start your college, you will have to deposit Rs. 2.50 lakhs by Demand Draft drawn in the name of Comptroller, MPKV, Rahuri immediately and submit the land record in support of your claim that the institute has 40 ha. Agricultural land in the name of your institution.

The proposed college will be governed by the rules and regulations of the Mahatma Phule Krishi Vidyapeeth, Rahuri in operation and made from time to time. The brief outline of the conditions is also attached herewith.

After receiving your consent, Demand Draft and copy of the land records, you will be required to complete all the infrastructure facilities as required for conduct of the classes. After hearing from you, a committee under the Chairmanship of Director of Instruction of the University will visit your institute and after receiving the satisfactory report, final permission to admit the students will be granted to you.


I hope, you will expedite the matter at your end so as to start the admission immediately. It will depend upon your response and we hope that your organization will be in a position to start the College and run it properly.
